### **Emails and Confidentiality**

The district can read your emails! If you're contacting anyone, including the ASC, for anything other than MPS business do not use the MPS email system. Not only can MPS read your email, but the email is archived and MPS can reach back and retrieve them whenever they wish to do so. It is not private, and it is not a violation of any privacy or confidentiality rights for MPS to assess your email account. Your email account belongs to MPS and you must be mindful that they may be reviewing and reading your email.

Beware when it comes to "saying" things on social media regarding your supervisor, School Board members, fellow colleagues, or others connected to the district. The district commonly peruses social media websites to see what you are talking about and to whom. Even joking around about someone or something can result in an investigation for misconduct under the MPS policy prohibiting bullying, harassment, and discrimination.

Your speech may be protected under the First Amendment, which protects you from criminal prosecution, but it is not protected from violations of District policy.

## Membership Dues and Recruitment

In addition to ASC's long tradition of representing administrator's who have been accused of misconduct, the ASC is introducing many new exciting resources and programs for administrators.

In order for administrators to avail themselves these benefits they must be a member of the ASC. Our policy continues to be that in order to receive assistance from the ASC, whether its information, counseling, or advocacy, one must already be a member.
