Dear ASC Members,

I want to congratulate you on another school year in which our members made MPS stronger and more successful. The year was filled with countless challenges where you were asked to do more with less time and resources. ASC members rose to these challenges. As an organization we have continued to have a greater voice on policies and procedures throughout the district.

We have fought for more pay, greater benefits, more manageable workloads, job protection, and safer working environments. We have had numerous wins this past year.

Our members will be seeing a 4.1% raise and a \$2,000 step increase. We have been successful in representing members in disciplinary hearings and with complaints of bullying and harassment. The administration has made changes to the disciplinary process as it pertains to our members as a result of our representation! We played an integral role in getting the referendum passed which will ensure resources for our students and protect jobs.

have demanded and received changes to the upcoming calendar. We will continue to do this so that the calendar makes sense. We have been successful in petitioning for individual pay adjustments for members. We working with board members to get a pay **ASC** for members so compensation is more predictable and equitable.

I continue to serve on the MPS Safety Committee. On this committee I am working to make your workplace safer, which includes getting metal detectors back into the schools. I also now serve as member and fiduciary on the MPS Pension Board.

Please note, we have seen a rise in disciplinary matters pertaining to the failure to report incidents to the regional superintendents. If you have any question as to whether an incident should be reported please error on the side of caution and notify your regional.
