Executive Director's Updates

This school year has presented many challenges and uncertainties but our members have not wavered in their leadership, dedication, and commitment to the students and families of MPS.

The ASC remains committed to fighting for improved working conditions, increases in pay, expanded professional development opportunities, and enhanced safety. Though new challenges will certainly arise, our shared vision of excellence and collective resolve will remain steadfast.

Employee Rights Division and Complaints

The Employee Rights Division at Central Office is required to handle complaints about bullying, harassment, discrimination, and intimidation among employees. However, this provision is reportedly being used by some employees to file complaints against administrators for relatively minor grievances, such as being required to follow basic workplace expectations.

As a result, administrators often face uncomfortable investigations, leading to minor disciplinary actions, such as mandatory training sessions. This frequent use of complaints has created a challenging environment, with administrators feeling targeted over issues that may not warrant serious review.

It is alarming and disappointing to receive a notice that a complaint has been filed against you, and you are entitled to ASC representation at any hearing that follows. If you are contacted and told that you are being investigated for bullying and harassment please contact the ASC right away. I will prepare you for the hearing and attend the hearing with you.

Child Abuse Reporting

Wisconsin law mandates that all school staff report any suspicion of child abuse or neglect directly to Child Protective Services (CPS).

It is not for you to determine whether your suspicion is valid, only to report your suspicion to CPS. Staff should not seek permission from superiors before reporting, as state law provides them with immunity when they act in good faith.

Reports are confidential, and mandated reporters are protected from repercussions by law. When you do suspect abuse or neglect, it's essential to contact CPS without delay. Failure to do so can lead to criminal charges, fines, and job loss.

Retirement Planning Meetings

Retirement marks an essential milestone, and it's never too early to begin planning. Whether you're approaching retirement or still have years to go, a retirement planning meeting can provide you with guidance and support tailored to your needs. We recognize that retirement planning can feel overwhelming, but our goal is to simplify the process and ensure you're prepared.

These meetings will guide you through the details of your pension plan and benefits, covering eligibility requirements, payout options, and survivor benefits. Your retirement is a significant chapter, and we want you to feel fully supported as you plan for it. Finance and Responsibility

Please be aware that one of the primary causes for misconduct proceedings against our members has been in instances where there is an allegation of financial wrongdoing. Administrators, particularly principals and assistant principals, may face termination for alleged financial misconduct, regardless of intent.

MPS places ultimate accountability on building leaders for any violations occurring under their supervision—even those beyond their direct knowledge or control. Given the serious potential consequences, administrators are strongly advised to conduct regular audits, review financial documents such as timesheets meticulously, and participate in district-offered financial training to minimize both financial and disciplinary risks. ACT 10 Found Unconstitutional

On December 2, 2024, Dane County Judge Jacob Frost ruled provisions of Act 10 unconstitutional. Judge Frost ruled that Act 10 violates the equal protection guarantees in the Wisconsin Constitution by dividing public employees into two classes: "general" and "public safety" employees. The decision will certainly be appealed to the Wisconsin Supreme Court. We will keep you updated on further developments as they arise. This is exciting news and brings us one step closer to reclaiming the collective bargaining rights which were stolen from you in 2011.
